



ARTICULATION/TRANSFER AGREEMENT Chemeketa Community College Health, Human Performance & Athletics to Linfield University Health, Human Performance & Athletics **Exercise Science**

Identify Both Institutions:

The parties to this Articulation and Transfer Agreement are Chemeketa Community College (Chemeketa) located at 4000 Lancaster Drive NE, Salem OR 97305, and Linfield University (Linfield) located at 900 SE Baker Street, McMinnville, OR 97128.

Effective Date:

This agreement is effective beginning the 2021-2022 academic year, and shall remain effective until June 30, 2026 or 5 years, whichever comes first.

Purpose/Transfer Agreement:

The purpose of this agreement is to develop, maintain, and promote a smooth academic pathway that supports successful student transition to Linfield and the Exercise Science program. This agreement does not guarantee admission to Linfield, nor does it carry any other promises, such as financial aid or course placement, unless otherwise noted.

This agreement is based on an evaluation of the rigor and content of the Technical and General Education Courses at both Chemeketa and Linfield. It is agreed that students transferring from Chemeketa's Health and Human Performance to Linfield's Health and Human Performance will be given credit for the courses listed below.

Students may transfer up to 72 semester credits (108 quarter credits) from regionally accredited two-year institutions. To be transferable, coursework must be of college level, similar to courses in the Linfield Catalog, and be completed with a grade of "C" or higher. Quarter credits transfer at two-thirds credit, i.e. 3 quarter credits equals 2 semester credits.

Students transferring from Chemeketa Community College with a completed Core Transfer Map will have completed at least 5 of the LC requirements and those who have earned their AAOT will have completed at least 7 of their LC requirements.

Other transferable courses to consider taking at Chemeketa CC that will count toward the major or a

prerequisite in the major.

Terms of Review/Re-evaluation: This agreement is subject to re-evaluation by both colleges for continuation and/or modification not less than 90 days prior to the termination of the agreement. Continuation and/or modification to this agreement must be provided in writing by Chemeketa to Linfield's Vice President of Academic Affairs and by Linfield to Chemeketa's Dean of Health, Human Performance, and Athletics, and approved by Chemeketa's Vice President of Academic Affairs and Linfield's Provost and Vice President for Academic Affairs.

Termination: Either college can terminate this agreement by providing written notice no less than 90 days prior to the intent to terminate. Chemeketa must provide this notice to Linfield's Dean of the College of Arts and Sciences and by Linfield to Chemeketa's Dean of Health, Human Performance, and Athletics.
