







**SUBJECT: Memorandum of Agreement for Army SROTC for Chemeketa Community College**

1. Purpose: The purpose of this memorandum is to provide for enrollment of students from the Chemeketa Community College Chemeketa Community College in the Oregon State University Army Senior Reserve Officers' Training Corps (SROTC) Program.
2. General:
  - a. The US Army has an agreement to provide Army SROTC instruction at Oregon State University, see enclosure 2. Copies of this agreement (DA Form 918A) are on file at Oregon State University and Headquarters, U.S. Army Cadet Command.
  - b. The Army SROTC program will provide SROTC instruction and training for qualified students enrolled from Chemeketa Community College on the same basis as for students enrolled in SROTC at Oregon State University. The terms and conditions set forth in Oregon State University SROTC agreement are applicable to Chemeketa Community College.
  - c. Chemeketa Community College agrees to authorize its students to enroll in and attend Army SROTC classes offered at the Oregon State University.
  - d. Chemeketa Community College students enrolled in SROTC program are responsible for making their own arrangements for transportation to and from the Oregon State University for those SROTC activities requiring their attendance.
  - e. Chemeketa Community College agrees that no SROTC unit will be established or maintained at a school that unlawfully discriminates with respect to admission or subsequent treatment of students in a manner prohibited under applicable state and/or federal law, and applicable federal regulations and other policies.
  - f. Chemeketa Community College will comply with applicable federal and state law and Department of Defense (DoD) policy prohibiting discrimination based upon race, color religion, sex (including gender identity), sexual orientation and/or national origin. No ROTC unit will be established or maintained at a school that unlawfully discriminates in a manner prohibited under applicable federal and state laws and DoD policy with respect to Military Service members and federal employee civilian staff to the ROTC unit; this prohibition applies to any requirements regarding the status, privileges or benefits accorded to such persons under law, DoD policy, state or school policy.




Enclosure 1: Supplemental Considerations for the SROTC program

1. Pursuant to the agreement of the memorandum for Army SROTC for Chemeketa Community College, it is hereby agreed between the parties within the agreement that the following is amended as follows:


- a. SROTC reserves the right to cancel any Course for which fewer than five (5) Students have enrolled one week prior to the Course start date, except when other arrangements are made with OSU.
- b. Student Privacy: FERPA Compliance, All parties must comply with all applicable provisions of the U.S. Family Educational Rights and Privacy Act of 1974 ("FERPA"); 20 U.S.C. §1232g (1974) and the Code of Federal Regulations appertaining thereto. Neither party shall be permitted to authorize any further disclosure of educational records of students of the other party to persons or entities who are not a party to this Agreement without first having received permission of the other party and having obtained assurances that the other party has fully complied with the provisions of FERPA. Any permitted disclosure to persons or entities not a party to this Agreement shall be under the conditions that no further disclosure by such parties shall be permitted.
- c. Termination. This Agreement may be terminated at the end of any academic term by any of the parties by giving six (6) months written notice of such intent to all other parties.


