**Articulation and Transfer Agreement for
Baccalaureate Completion Program for RNs (RNBS)**

This Agreement shall be in full force and effect from the date of the last signature, and shall remain in effect unless terminated by written agreement between both parties.

It is agreed that students transferring from Chemeketa Community College (CCC) to Oregon Health & Science University School of Nursing (OHSU), upon acceptance by OHSU, will be given full transfer credit for the OHSU courses listed below based on CCC students having completed equivalent courses from CCC.
