



# Memorandum of Understanding Health Informatics SIM Lab

# Chemeketa Community College & Oregon Institute of Technology June 19, 2009

This memorandum of understanding creates an agreement between the Oregon Institute of Technology (OIT) and Chemeketa Community College (Chemeketa) for the purpose of making available access to certain software application(s) for the expressed purpose of supporting educational opportunities for Chemeketa students.

It is expected that this relationship and effort will better serve students and create mutual benefits for both institutions. It is expected that this effort will enable Chemeketa to better serve its students by using real-world and current health information technologies offered through OIT. It is expected that this effort will increase public awareness of the benefits of OIT-Chemeketa collaboration in service to students in the area of health informatics, health information management and health care information technology.

## Electronic Medical Record Practice Management System

 During Summer 2009, an agreement will be signed and an implementation plan developed to ensure access by Chemeketa to the OIT SIM Lab Electronic Medical Record (EMR) application, GE Centricity Practice Solution (CPS) 2006.

#### SIM Lab Utilization

- OIT will provide access to the GE Centricity SIM Lab EMR for use by three (3) classes offered by Chemeketa during Fall term 2009 and Winter term 2010.
- Access will be limited to three classes delivered at Chemeketa during the Fall term 2009 and Winter term 2010, with approximately 25 -30 students using 25-30 classroom computers. The computers will be equipped with Windows XP Professional ® Operating system.
- A minimum class size of 20 students per course will be required.
- OIT will provide information technology (IT) set up and support from the SIM Lab to ensure adequate student and faculty access to the application.
- During 2009-2010, Chemeketa and OIT will explore the a strategic agreement related to the
  expansion of SIM Lab access for Chemeketa students, including nursing, computer science, EMT
  or other appropriate Chemeketa students.

## Course Design and Development

- Chemeketa will be responsible for total course and curriculum design and development for any course(s) that involve access to the OIT SIM Lab.
- OIT will provide access to certain user guides and other training materials to assist Chemeketa in curriculum design and development.
- OIT will not provide curriculum or course design, development or delivery functions.

#### Marketing

 OIT and Chemeketa agree to develop joint marketing initiatives to publicize the Chemeketa--OIT SIM Lab utilization, including in catalogs, websites, and other materials, as resources and time permit.

#### Pricing
